

Pedro Bay Benefits Corporation Short-Term Vocational Education Scholarship Program Administered by the Bristol Bay Native Corporation Education Foundation

Bristol Bay Native Corporation Education Foundation will accept applications from Pedro Bay Corporation shareholders who are in need of financial assistance to attend short term training to enhance their work or career opportunities. Recipients will be awarded a maximum \$2,000 per scholarship, depending on the cost/length of the training; maximum one scholarship per program and one scholarship per calendar year. NOTE: The scholarship program is limited by budget, therefore some eligible applicants may not be awarded a scholarship and there is no guarantee of funding.

The eligibility and other requirements are:

- 1. Pedro Bay Corporation shareholder
- 2. Submit a complete scholarship application
- 3. Provide verification of application/enrollment from the training organization/company **and** include a description of the training
- 4. Show financial need
- 5. Attach a letter of request that outlines:
 - ✓ Your employment/training goals
 - ✓ How your training will relate to your employment goals
 - ✓ Employment opportunities after completion of the training
